Granted are the powers to execute such special hunt license applications and endorsements of such special license funds. This power of attorney shall be revoked by disability of the Grantor, and shall otherwise continue in full force and effect until revoked in subsequent writing.

TG's Trophy Hunts

**Payment:** Hunts will not be held without deposit including private land tags. Fifty percent 50% is due upon successfully drawing a tag. TG's Trophy Hunts will notify you of your draw results and final payment will be due 30 days prior to hunt date unless other arrangements have been made. Make checks payable to TG's Trophy Hunts. If the undersigned defaults on any payment due under the terms of this Agreement, the hunt will be cancelled, state license fees will not be refunded and any payments already made will be forfeited.

Private land hunts require fifty percent 50% to hold tag. Balance due is required 30 days prior to hunt start date unless other arrangement have been made.

**Cancellation by Hunter:** If you cancel, and we have adequate time, as determined by TG's Trophy Hunts to resell the hunt, we will refund your deposit less our processing fees and incurred expenses. Under certain circumstances and by agreement of both parties, the deposit can be transferred from one party to another or to a future hunt or service.

**Cancellation by Outfitter:** If we are unable to provide outfitting services due to unforeseen circumstances, as determined by TG's Trophy Hunts, we will attempt to make other arrangements as acceptable by the hunter. If an agreement cannot be reached the hunt will be cancelled and payment to TG's Trophy Hunts will be refunded. TG's Trophy Hunts will not be responsible for reimbursement of license fees paid to the State of New Mexico or any other expenses related to the hunt.

**Legal Jurisdiction:** All matters pertaining to the validity, construction and effect of this Agreement shall be governed by the laws of the State of New Mexico. It is agreed that the proper jurisdiction and venue for any legal dispute which may arise concerning this Agreement shall be in the New Mexico Twelfth Judicial District Court in Ruidoso NM.

**Hunts Include:** Meals, lodging, and guide service, field dressing and caping of game and packing to hunting headquarters.

**Hunts Do Not Include:** Personal items, weapons, meat processing or shipping, taxidermy costs (including preparation, shipping, crates, etc.) or travel other than field transportation.

**Wounded Animals:** If the hunter wounds and animal, the hunt will be suspended to locate the

wounded animal. If the wounded animal has not been recovered within 24 hours, the hunt will resume and the hunter can shoot another animal. If the hunter wounds a second animal, the hunt will be suspended for 24 hours to locate the animal. If the animal cannot be located the hunter may elect to continue the hunt with an additional fee of \$1500.00

**Physical Condition:** Hunts may require travel by foot or vehicle in rugged terrain and or inclement weather conditions. Hunters acknowledge that a certain level of physical conditioning is required and assumes full responsibility for his or her fitness for the activity. Hunter further acknowledges that his or her physical condition, as assessed by TG's Trophy Hunts may impact hunt conditions and quality.

**Alcohol Consumption:** TG's Trophy Hunts will not provide any alcoholic beverages in the field or at camp/lodging. There will be no alcohol consumption while in the field and no excessive alcohol consumption at the camp/lodge.

**Terms and Conditions Please read carefully.** Executing the following release is a condition of participating in this guided hunt and a consideration of the services of TG's Trophy Hunts. Unless agreed to and signed, this hunt contract is not valid. Signing and returning the following release constitutes acceptance of all the terms and conditions stated in the agreement.

#### **Assumption of Risk and Release from Liability**

I hereby acknowledge the hunting trip that I am participating in under the agreements of TG's Trophy Hunts, its employees, agents, and associates involves the risk and danger which are inherent of hunting fishing, and wilderness travel, including but not limited to hazards of traveling by motorized vehicle or horseback, hazards of carrying and being in possession of firearms, and ammunition and or bows and arrows, hazards of being exposed the elements of nature, hazards of being in areas where hunters are likely to be present, hazards of being, camping and traveling in remote wilderness areas, hazards related to encounters with wildlife, animals and insects and hazards arising from accidents, acts of god, illness and forces of nature. I hereby remise , release and forever discharge TG's Trophy Hunts from any claim, action, proceeding, liability, injury, costs, sums of money or other obligations arising out of or in connection with the aforesaid trip.

I further accept and assume all risks of personal injury or death and loss or damage to property while participating in the said guided hunt, including negligence of TG's Trophy Hunts and its employees, agents, and associates, and that I do so voluntarily. Also, that no guarantee of success has been given or implied in writing or orally. Contract made in the State of New Mexico, USA, and is subject to the laws of the State of New Mexico, USA.

### Parental Waiver and Release


